The Chief Engineer Shimla Zone HPPWD Nigam Vihar Shimla H.P on behalf of Governor of H.P invites the item rate bids from approved contractors registered with HPPWD for construction of works detailed in the table. The bidders are advised to note the minimum qualifying criteria specified in clause 4 of Instructions to Bidders (ITB). The bidders may submit bids for following work:-

The application for purchase of Bidding documents ( and additional copies ) may be purchased from the office of Executive Engineer HPPWD Jubbal from 12.07.2011 1000 Hours To 4.08.2011 1700 Hours or a non refundable fee (Three sets ) as indicated in the form of cash or demand draft on any scheduled bank payable at Jubbal in favour of Executive Engineer HPPWD Jubbal Distt Shimla. Interested bidders may obtain further information at the same address. Bidding documents requested by mail will be dispatched by registered post /speed post on extra amount of Rs 1000. The Executive Engineer HPPWD Jubbal Distt Shimla will not be held responsible for the postal delay if any, in the delivery of the documents or non receipt of the same.

3. Bids must be accompanied by security of amount specified for the work in table payable at Jubbal and drawn in favour of Executive Engineer Jubbal Distt Shimla. Bid security will have to be any forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.

4. Bids must be delivered to Chief Engineer (SZ) HPPWD Nirman Bhawan Nigam Vihar Shimla 171002 on or before 16.00 hours on 06.08.2011 and the technical bids will be opened on 08.08.2011 at 1130 in the office of

Chief Engineer (SZ) HPPWD in the presence of the bidders who wish to attend .If the office happened to be close on the date of receipt of bids as specified ,the bids will be opened on the next working day at the same time and venue .

5. A pre-bid meeting shall be held on 26.07.2011 at 1100 hours in the Conference Room of PWD , Nirman Bhawan Nigam Vihar in the office of Chief Engineer (SZ) HPPWD to answer clarify the issues and to answer questions on any matter that may be raised at that stage as stated in clause 9.2 of the "Instructions to bidders " of the bidding document. If the office happened to be closed on the date of pre bid meeting as specified, the pre bid meeting shall be held on the next working day at the same time and venue .

6. The bid comprise of original document i,e affidavits ,earnest money ,bid security ,solvency certificate from bank

7. The prospective bidder must submit the hard bound bid document with all pages numbered in two cover packets indicating 'Technical Bid ' & "Financial Bid ' in separate covers.

8. The other details can be seen in the bidding documents.

9. The defect liability period for the above work shall be 3 years and contractor is expected to do normal maintenance during this defect liability period and no extra payment shall be released for this maintenance

10. The bidders shall have to append the proof of having requisite machinery shown in the tender document. In the event of award of work, the contractor has to commission the Hot Mix Plant of indicated capacity within 25 km to site of work.
